/**Section 7****Family Memberships****Check here**  if you are applying for the **Family Membership** discount described in **Note 7** below: please complete and submit all relevant applications in the same envelope, remitting the required dues for each adult plus (as discounted) **\$132** for each *Pee-wee* and **\$252** for each *Junior*. **Note-** you can download the shorter *Pee-wee/ Junior* application from the website *Membership Info* page or request printed versions by calling or e-mailing the Office- see the letterhead on page 1 for contact info .**Notes:**

- 1. New and returning Full Members** can claim a **discount** and pay the 2011 rate of **\$1065.00** for the 2012 season as opposed to the full 2012 rate of \$1090.00. To obtain this discount, complete **Section 4** & submit your **full** dues by March 1, 2012 by **cash, cheque or money order only**. If paying by other means **or** paying later than March 1, you must pay the full \$1090.00.
- The **Value and Limited Classifications** accept renewals from existing members in these classifications **only**, and are **not** available to new entrants. **Value** members may play **7 days a week** with tee-off times restricted to **11:00 AM and later** (with earlier times permitted for official Club tournaments and Avon Valley Thursday Seniors play). **Limited** members may play **weekdays only**, with tee-off times restricted to between **10:00 AM and 3:00 PM**.
- Intermediate members** must be **19** but not yet **30** years of age by **March 1, 2012** and must be **Shareholders** (see section 2).
- Pee-wee** members must be 8 but not yet 13 years of age and **Juniors** must be 13 but not yet 19 as of **March 1, 2012**. *Pee-wees & Juniors* who **have a handicap of 18 or better** and who have been **approved by the Junior Development Committee for booking privileges** may book 3 days in advance for **weekday** play up to 4:00 PM (later tee times may be released on the day of play). On **weekends and holidays**, they may book for 2:00 PM & later. **In all cases, play must be with an adult**. No share is required for *Pee-wees/ Juniors*.
- If you wish to request election to the **Leave of Absence/ Social Membership** status as defined in the **By-laws**, please enclose a letter no later than **March 1, 2012** stating your reason. A **full member** is entitled a **maximum of 3 instances of Leave of Absence** during his/ her entire period of membership. **Value, Limited and Intermediate** members are entitled to one such instance, and **Pee-wees/ Juniors** are not permitted any.
- Family Memberships** are available to four or more family members (includes **parent(s)/guardians** and **dependents under the age of 19 years**) in the same household: the **dependents** would receive a (rounded) 20% discount on their *Pee-wee/ Junior* dues: see section 7 above.
- Please note:** the Club's **By-laws** set a limit on membership. Although openings are currently foreseen, in the event of oversubscription the priority for acceptance will be as guided by Club policy and receipt by deadline may become a factor. Accordingly, please ensure your application (for renewals as well as new membership) is received by the Club no later than **March 1, 2012**.

## Membership Guide

A request was raised from a member during the May 2, 2011 *Annual General Meeting of Shareholders* to reinstate the Club's Member's Guide which had been distributed to all members during the 1995 and 2000 seasons. To recall, the 2000 version included the listing of the Board of Directors and the (then) Ladies' Division Executive, lists of management staff and Honorary Life Members and other information such as Pro Shop hours, notes on booking procedures, marshalling, dress regulations, playing times and restrictions. Finally it included a list of over 750 members by surname/ first name, telephone numbers and playing classification.

Since the year 2000 most organizations have become governed or guided by the requirements of privacy legislation. In this instance, since information submitted by members on their application forms is not specifically given for purpose of publishing a Member's Guide, to publish their information the Club would first be required to:

1. obtain specific written permission from members to share their information
2. identify the information to be shared
3. specify to whom the information may be disclosed and how the information may be used;

In respect of which, all members (except Pee-wees & Juniors, who for greater safety will not be included) are now asked to complete the following:
