## Section 4:

## Family Membership information

**Family Memberships** are available to *four or more family members* including 1 or 2 parent(s)/guardian(s) plus the requisite number of *dependents* under the age of 19 years & living in the same household. The *dependents* would receive a (rounded) 20% discount on their Junior and/ or Pee-wee dues, i.e. **\$295** for each Junior and **\$152** for each Pee-wee. If applying for family membership, an **adult applicant** should complete and submit this form with his/ her information and submit it together with the requisite additional applications all in a single envelope. Note that the 2017 **Junior/ Pee-wee application form** can be downloaded from the website *Membership Info* page or requested from the Office. Ensure that all required dues and fees for all applicants are submitted. Include either a single payment for the total amounts of all applicants, or separate payments for each applicant as preferred. Note that any new or returning **Full members** included in a family membership application may also apply the "cash or equivalent" discount (see section 3A) if the *deadline* and *payment option* requirements are met.

### Notes:

1. All members (except Juniors/ Pee-wees) who are not already Shareholders must purchase a share for a one-time charge of \$115.00 (unless designated to enjoy another Shareholder's playing privilege in accordance with the Club's By-laws: if you believe this applies to you, call the Office for verification). **Share purchase/ tax is refundable upon resignation of membership and surrender of the share.**
2. New and returning **Full Members** enjoy full booking/ playing privileges. As outlined in **Section 3A**, they are also eligible for a **discounted rate** of **\$1242.00** for the season if received in full by **March 3, 2017** by **cash, cheque or money order** only (*date adjusted in light of winter weather-related mail disruptions*)
3. The **Value and Limited Classifications** accept renewals from existing members in these classifications **only**, and are **not** available to new entrants. **Value** members may play **7 days a week** with tee-off times restricted to **11:00 AM and later** (with earlier times permitted for Club tournaments and AVGCC Thursday Seniors play). **Limited** members may play **weekdays only**, with tee-off times restricted to between **10:00 AM and 3:00 PM** (exceptions for Thursday Seniors & tournaments). **Twilight** members may play weekdays after 4:00 PM
4. **Pee-wees** must be **8** but not yet **13** years of age and **Juniors** must be **13** but not yet **19**, both as of **March 1, 2017**. Clinics, tournaments & fun nights are organized these groups throughout the summer. Other play must generally be with an adult, noting that extended playing/ booking privileges can be granted depending upon individual skill levels determined by the Junior Development Committee. **No share** is required for Pee-wees/ Juniors. **Family Memberships** with reduced Junior/ Pee-wee dues are available as described in Section 4 above.
5. **Intermediate** members have full playing and booking privileges and must be not older than **30** upon joining/ renewing: **Senior Intermediates** also enjoy full privileges and must not be older than **40** when joining/ renewing. Each sub-classification requires members to be **Shareholders** (see Note 1)
6. If applying for **Leave of Absence/ Social Membership** status as defined in the By-laws, submit a written request to the Director, Member Services c/o the office no later than **March 1, 2017**. A full member is entitled a maximum of 3 periods of such status during their time of membership, Value, Limited & Intermediate members just one such period, and Pee-wees/ Juniors are not permitted any.
7. **Please note:** the Club's By-laws set a limit on membership. Although openings are currently foreseen, in the event of a surplus of applications the priority for acceptance will be per Club policy and date of receipt of applications will become a factor. Please ensure your application for membership **or** renewal is received at the Club no later than **March 1, 2017**.
8. All equipment left with the Club under the care and storage services is either attended during operating hours or kept under lock and key after hours with security monitoring in effect. Notwithstanding, users of these services (or the Club's facilities in general) are advised that the Club accepts no liability for theft or damage to members' property at any time.
